**IMPORTANT NOTICE REGARDING RESCHEDULING OF INTERVIEWS OF

In view of the unprecedented surge in the number of COVID-19 cases in the State, the Commission has started taking the interviews for various Posts and Recruitment Examinations in online mode since 30.04.2021.
