ADVERTISEMENT

The Public Service Commission, West Bengal will hold the **West Bengal Judicial Service Examination**, **2022** in accordance with the existing rules for recruitment to the posts in West Bengal Judicial Service. The necessary particulars are stated in the following paragraphs. A candidate should verify from the notified rules that he/she is eligible for admission to the examination. The conditions prescribed cannot be relaxed.

The W.B.J.S. Examination, 2022 will be held in three successive stages, viz., (i) Preliminary Examination (MCQ Type), (ii) Final Examination (Conventional Type – Written) and (iii) Personality Test. A number of candidates to be selected on the results of the Preliminary Examination will be allowed admission to the Final Examination and a number of candidates to be selected on the results of the Final Examination will be called to appear at the Personality Test.

The Preliminary Examination will be held in Kolkata (Code - 11) and Darjeeling (Code - 12) in <u>March</u>, 2023 or thereabout. Only candidates of Kalimpong District and three Hill Sub-divisions of Darjeeling, viz., Darjeeling Sadar, Mirik and Kurseong will be allowed to appear at Darjeeling Centre. The Final written Examination will be held at Kolkata in <u>May</u>, 2023 or thereabout. Personality test will be held thereafter in the office of the Public Service Commission, West Bengal, in Kolkata.

There shall be no separate Qualifying marks for any individual paper or for the Personality Test. The Commission shall have discretion to fix qualifying marks in the aggregate.
